The Flint Community School District is submitting this Request for Appeal/Waiver to the FCC regarding the following denial by USAC: **"FCC rules stipulate that the invoice deadline date for FRN's cannot be extended past 120 days from the current invoice deadline date for the FRN (4/22/2015). Since this FRN cannot be extended past 8/22/2015, your appeal is denied."**

The Flint Community School District offers a copy of the Administrator's Decision on Invoice Deadline Extension Request an approval for the extension request dated September 22, 2015 for FRN's 2474164, 2489558, 2489562 and 2489565.


The above denial basis is further unclear based upon an incorrect description of a single FRN listed as FRN(4/22/2015) and not the following four (4) FRN's 2474164, 2489558, 2489562 and 2489565.

The Flint Community Schools have undergone multiple top administration personnel changes during the previous four (4) E-rate years making follow-through an ambiguous goal. Authorized signers having changed multiple times make continuity a difficult goal to achieve.

The boys and girls of Flint Community School District should not be denied funding for Form 471 # 899468 because of this incorrect denial. A second invoice extension of 120 days would permit enough time to prepare and submit new Form 472 documents for the four (4) FRN's 2474164, 2489558, 2489562 and 2489565.
