Invoice Deadline Waiver Request:

We are requesting a waiver on the 2014 2015 erate invoice deadline. As a small rural New Mexico School District our IT challenge has been ongoing.

Our district has one IT Director that is charged with E-Rate submissions. In July 2014, the IT Director resigned his position. Since then, two IT Directors have been hired and both have resigned their positions. We have not been able to keep that position filled long enough to address E-Rate related forms and submissions.

On November 3, 2015, invoice extension requests were faxed in to USAC Schools and Libraries Division. On March 9, 2016 a phone call was made to follow up on the approval on the invoice extension. It did not appear the request was approved. However, the school district has not received any denial letters regarding these FRN's.

We respectfully request that our district be allowed to submit 2013 reimbursements as we have appointed E-Rate responsibilities to an existing employee. In addition, we have since employed resources at the State and private sectors to make sure that this does not happen again.

Please consider approving an extension to file the reimbursement requests. This amount of money may seem small but to us it is substantial.
