Dear Ms. Dortch:

On April 25, 2016, representatives of Charter Communications, Inc. ("Charter") had a telephone call with Joel Rabinovitz, Betsy McIntyre, Drew Erber, and Kiley Naas of the Federal Communications Commission ("Commission") to discuss certain confidential material submitted by Charter in the above-referenced proceeding. Participating for Charter were: Alex Hoehn-Saric and Larry Christopher; and Jared Freedman, Leah Tulin, Bradley Humphreys, and the undersigned of Jenner & Block LLP. In addition, Ms. Tulin and I had a second telephone conversation with Mr. Rabinovitz and Ms. Naas on April 27, 2016. During the calls, Charter agreed that it no longer claims confidentiality with respect to the following:

1. The explanatory parenthetical following the citation that appears in footnote 39 on page 9 of the letter from John L. Flynn to Marlene H. Dortch dated January 14, 2016 and filed in the above-captioned proceeding ("the January 14 Letter").
2. The redacted language in the first full paragraph on page 10 of the January 14 letter (but not the footnotes thereto).
3. The first sentence of Charter's October 13, 2015 response to Request 35(v) of the Commission's Information and Data Requests dated September 21, 2015.
4. The redacted language in the first full paragraph on page 54 of the Joint Applicants' November 2, 2015 Opposition to Petitions to Deny and Response to Comments (but not the third-party vendor contained therein).

5. The first sentence and the final sentence of paragraph 31 of the Reply Declaration of Michael L. Katz, attached as Exhibit B to the Joint Applicants' November 2, 2015 Opposition to Petitions to Deny and Response to Comments.
6. The redacted language in the portion of the paragraph immediately following the bullet points on page 2 of the letter from John L. Flynn to Marlene H. Dortch dated December 11, 2015 and filed in the above-captioned proceeding.
7. The redacted language in the fourth sentence of the third paragraph on page 3 of letter from John L. Flynn to Marlene H. Dortch dated December 15, 2015 and filed in the above-captioned proceeding.
