We acknowledge that once the authorization is granted, pursuant to this section of the rules, that they are subject to compliance with all applicable Commission numbering rules, numbering authority delegated to the states, and industry guidelines and practices regarding numbering as applicable to telecommunications carriers;

We also acknowledge that we must file requests for numbers with the relevant state commission(s) at least thirty (30) days before requesting numbers from the Numbering Administrators;

Our subsidiary, Barr Tell USA. Inc. has been a CLEC that has been providing telecommunication service(s) for the past 5 years directly to consumers. Barr Tell has well over 100,000 telephone numbers as a CLEC in several states directly from NANPA and the Pooling Administration. Therefore, providing service within sixty (60) days of



any new numbering resource activation date in accordance with 47 CFR § 52.15(g)(2) is no problem;

Our company, Telebroad, LLC with Filer ID 827233 is in total compliance and is a direct contributor to the Universal Service Fund contribution obligations under 47 CFR part 54, subpart H, its Telecommunications Relay Service contribution obligations under 47 CFR § 64.604(c)(5)(iii), its North American Numbering Plan and Local Number Portability Administration contribution obligations under 47 CFR §§ 52.17, 52.32, its obligations to pay regulatory fees under 47 CFR § 1.1154, and its 911 obligations under 47 CFR part 9; In addition, our subsidiary Barr Tell USA, Inc. has the USAC Filer ID 828949.
