On May 20, 2016, the undersigned, accompanied by Matthew Carter, Chief Executive Officer, and John Harrington, SVP-Regulatory, Litigation and Human Resources, of Inteliquent, met separately with the Offices of Chairman Tom Wheeler, Commissioner Mignon Clyburn, Commissioner Michael O’Rielly, Commissioner Ajit Pai, and Commissioner Jessica Rosenworcel. Inteliquent covered all of the information identified in the attached presentation. The company also emphasized that the Commission should address discrete issues in its Business Data Services proceeding in addition to last mile issues.
