**Request for Waiver
FCC Form 471 Filing Deadline for Funding Year 2016**

In accordance with Sections 54.719 through 54.721 of the Commission’s Rules, the following school districts, through its consultant, request a Federal Communication Commission waiver of the deadline for submission of the Funding Year 2016 Form 471 application. Consistent with the precedent in Academy of Math and Science¹, we ask the Commission to waive the filing deadline for the applications referenced in Table 1.


The referenced Form 471 applications were submitted within 35 minutes of the closure of the Form 471 filing deadline. System and process changes impacted effort throughout the 471 application cycle and introduced a ripple of delays leading right up to the filing deadline. Significantly higher labor hours were expended on a per-application basis when compared to prior funding years, dedicated to reentry of data and addressing errors only resolvable via USAC support. Late filing ultimately became unavoidable while addressing additional issues encountered through the final days and hours prior to the deadline. Please consider these circumstances during evaluation of this waiver request.
