Pursuant to Section 1.1206 of the Commission's rules, this letter provides notice that on June 9, 2016, Douglas J. Minster, Vice President – Government and Regulatory Affairs for Atlantic Tele-Network, Inc. ("ATN"), along with counsel Bryan Tramont and the undersigned, met with the following staff members of the FCC's Wireless Telecommunications Bureau regarding the above-referenced matter: Jean Kiddoo, Margaret Wiener, Gary Michaels, William Huber, and Mark Montano. In the meeting, we discussed the nature of ATN's domestic and international operations, ATN's history of bidding in FCC spectrum auctions, and the merits of the pending request by ATN's subsidiary SAL Spectrum, LLC for a waiver of Section 1.2110(f)(4) of the FCC's rules. In particular, ATN emphasized the unique circumstances presented in this waiver request, the purposes for which the rule was adopted, the record support for the waiver request, and the public interest benefits that would result from grant of the requested waiver, all as described in the pending waiver request and in ATN's reply comments.

Additionally, this letter provides notice that on June 10, 2016, ATN counsel Bryan Tramont spoke by telephone regarding this matter with Edward "Smitty" Smith of Chairman Wheeler's office and with Commissioner legal advisors Johanna Thomas, Brendan Carr, and Erin McGrath. In these conversations, Mr. Tramont emphasized the same points as described above.
