**MOTION FOR EXTENSION OF TIME**

On behalf of Garmin International, Inc. (“Garmin”), the undersigned counsel respectfully requests that the Commission grant a limited three business-day extension from Thursday, June 16, 2016, until Tuesday, June 21, 2016, for all interested parties to file reply comments in response to the Public Notice released on April 22, 2016, in the above-captioned dockets.<sup>1</sup>

The ten days specified in the Public Notice for preparation of reply comments is insufficient given the volume of the record and the significance of the issues. Garmin’s need to coordinate resources deployed throughout multiple international locations has compounded the work and necessitates this extension. Garmin has notified Ligado Networks’ counsel of this request by telephone and is also providing a copy to him by email and overnight delivery.


