(A) AT LEAST 30 DAYS BEFORE OPERATING ON CHANNEL 262C2 THE PERMITEE SHALL SUBMIT TO THE COMMISSION A MINOR CHANGE APPLICATION FOR A CONSTRUCTION PERMIT (FORM 301);

(B) UPON GRANT OF THE CONSTRUCTION PERMIT, PROGRAM TESTS MAY BE CONDUCTED IN ACCORDANCE WITH SECTION 73.1620;

(C) NOTHING CONTAINED HEREIN SHALL BE CONSTRUED TO AUTHORIZE A MAJOR CHANGE IN TRANSMITTER LOCATION OR TO AVOID THE NECESSITY OF FILING AN ENVIRONMENTAL IMPACT STATEMENT PURSUANT TO §1.301 OF THE COMMISSION'S RULES; THAT THIS PROCEEDING IS TERMINATING.
