GENTLEMEN:

SINCE I WAS MENTIONED BY NAME AND HAM RADIO CALLSIGN IN ATTORNEY LAUREN COLBY'S PETITION FOR RECONSIDERATION REGARDING HERBERT SCHOENBOHM, WT DOCKET No. 95-11 FILED 8/5/98, I WOULD LIKE TO TAKE THE OPPORTUNITY TO EXPRESS MYSELF.

MR. COLBY, IN AN ATTEMPT TO OVERTURN JUDGE LUTON'S DECISION AS WELL AS YOUR HAVING UPHELD IT, IS STATING THAT I PROMOTED SCHOENBOHM DETRACTORS TO CALL THE JUDGE TO TRY AND TAIN THE PROCEEDINGS AGAINST HIM. THAT'S UTTERLY RIDICULOUS BECAUSE OF TWO FACTORS: IT'S ILLEGAL AND I'D DO NOTHING TO JEOPARDIZE THE PROSECUTION'S CASE. SCHOENBOHM, IN MY ESTIMATION, IS NOTHING MORE THAN A TWO BIT THIEF, A LIAR, A HAM RADIO PARIHAH AND AN ANTI-SEMITIC GUTTERSNIPE WHO HAS AS MUCH RIGHT TO USE HAM RADIO AS CHARLES MANSON HAS IN KEEPING A KNIFE IN HIS CELL.

USING MY QSO WITH W200Q ON 1/17/98 AS A DEFENSE OF SCHOENBOHM IS INANE, SPECIOUS AND CHILDISH. IN THEIR REBUTTAL, MESSRS. PHYTHON, SCHONMAN AND FITZGIBBON CALL COLBY'S ALLEGATIONS "RUMOR, HEARSAY AND SPECULATION" AND FURTHERMORE THERE'S NO PROOF THAT THE JUDGE WAS EVER CONTACTED. IT'S 100% CORRECT. THE ONLY PERSON WHOM I KNOW WHO ACTUALLY DID SPEAK TO THE JUDGE WAS A TOM McMILLAN, WB3HGW, WHO CALLED TO ASK PERMISSION IF HE COULD VIDEOTAPE SCHOENBOHM'S FIRST HEARING SINCE, TOM, A PARAPLEGIC, HAS BEEN A TARGET OF VICIOUS ATTACKS BY SCHOENBOHM WHO WANTS TO DEHUMANIZE, HUMILIATE AND DESTROY A HANDICAPPED HAM WHO WORSHIPS THE HOBBY WHICH INDEED IS HIS OUTLET TO THE WORLD.

YOU MAY BE INTERESTED TO KNOW WHY I GOT INVOLVED IN A CONTACT WITH CHUPP WHO HAS IDOLIZED SCHOENBOHM FOR YEARS. IN FACT, HE WAS THE ORIGINATOR OF THE ON-THE-AIR HERBERT SCHOENBOHM LEGAL DEFENSE FUND WHICH IN REALITY CONSISTED OF BEGGARS PLEADING FOR FUNDS TO HELP THE PARIHAH FIGHT THE FEDERAL GOVERNMENT.

CHUPP'S DISLIKE OF ME WAS NOT PRIMARILY BECAUSE OF HIS INSISTENCE OF MY SO-CALLED EX PARTE VIOLATION WHICH NEVER EXISTED TO BEGIN WITH. THE REAL REASON IS BECAUSE HE HAS ALWAYS RESENTED MY STRONG ANTI-SCHOENBOHM SENTIMENTS WHICH INCLUDED EXPRESSION OF MY OPINION BY LETTERS TO THE F.C.C. TO CHUPP, NO ONE HAS HAD THE RIGHT TO CONFRONT A PARIHAH HE IDOLIZES. CRITICISM IS OUT OF THE QUESTION. CHUPP HAS ALWAYS EXPECTED EVERYONE TO ACCEPT THE VICIOUS VIGILANTISM OF SCHOENBOHM AS RIGHTEOUS.

WTB PROSECUTION WRITES THAT SCHOENBOHM'S PETITION IS WITHOUT MERIT AND THE REASON FOR IT IS TO EXTEND HIS TIME ON THE AIR. THAT'S EXACTLY TRUE. CONSTANTLY I HEAR ON-THE-AIR STATEMENTS BY SCHOENBOHM FANS THAT ALL OF THESE APPEALS WILL KEEP HIM ON THE AIR FOREVER. AND THAT FINALLY YOU'LL BECOME FRUSTRATED TO THE POINT OF RENEWING HIS LICENSES. UNLESS I'M SADLY MISTAKEN, COLBY'S NEXT STEP WILL BE APPELLATE COURT IN D.C. WHICH WILL ASSURE SCHOENBOHM'S PRESENCE ON THE AIR FOR A CONSIDERABLE AMOUNT OF TIME. I CERTAINLY HOPE THAT DURING THE UPCOMING PENDENCY, YOU WILL EXERCISE POWER BY PREVENTING HIS TRANSMITTING.
