WIRELESS TELECOMMUNICATIONS BUREAU'S
REQUEST FOR ADMISSIONS OF FACT FROM
ASSOCIATION FOR EAST END LAND MOBILE COVERAGE

1. The Chief, Wireless Telecommunications Bureau, by his attorneys and pursuant to Section 1.246 of the Commission's Rules, 47 C.F.R. § 1.246, hereby requests that, within ten days of the date of this request, the Association For East End Land Mobile Coverage ("East End") shall admit to the truth of the facts set forth below. Each response shall be identified by the same number as the subject admission request and shall be made under oath or affirmation by the person making the response.

Admissions

1. East End does not hold any FCC authorizations permitting it to provide for-profit communications service.
2. Norcom Communications Corp. ("Norcom") provided some of the funds for the start-up of East End.
3. Norcom provided all or substantially all of the funds for the start-up of East End.
4. Norcom has paid some of the legal fees incurred by or on behalf of East End for any purpose.
5. Norcom has paid all or substantially all legal fees incurred by or on behalf of East End for any purpose.
6. Norcom has paid some of the legal fees incurred by or on behalf of East End in connection with: (a) the formation of East End; (b) applications for Station WPAT918 ("Station"); (c) construction of the Station.
7. Norcom has paid all or substantially all legal fees incurred by or on behalf of East End in connection with: (a) the formation of East End; (b) applications for the Station; (c) construction of the Station.
8. East End has no members.
9. East End has never had any members.
10. Robert Nopper, individually, participated in the formation of East End.
11. Robert Nopper, individually, prepared all documents relating to the formation of East End.

12. Robert Nopper, individually, assisted in the preparation of East End's FCC application(s) for the Station.
13. Robert Nopper, individually, prepared East End's FCC application(s) for the Station.
14. Robert Nopper, as a principal of Norcom, participated in the formation of East End.
15. Robert Nopper, as a principal of Norcom, prepared all documents relating to the formation of East End.

25. East End and Norcom have the same mailing address.
26. Norcom has entered into resale agreements with intermediaries allowing these intermediaries to resell air time over the Station.
27. The intermediaries referred to in item (26) above may, pursuant to resale agreements with Norcom, resell air time over the Station on a for-profit basis.
28. The intermediaries referred to in item (26) above have, pursuant to resale agreements with Norcom, resold air time over the Station on a for-profit basis.

29. The Station was constructed and in operation within one year of the grant of the license to East End.

30. The Station did not have 70 mobiles in operation for each of its authorized channels within three (3) years of grant of the license to East End.

31. Norcom and East End have utilized the same: (a) accountant(s); (b) attorney(s); (c) engineer(s).

32. East End and Norcom have utilized the same office equipment.

33. East End and Norcom have utilized the same office personnel.

34. Norcom has sold air time over the Station.

35. Norcom has sold air time over the Station only on a non-profit, cost shared basis.

36. Norcom has sold air time over the Stations on a for-profit basis.

37. Norcom has controlled the daily operations of East End.

38. Norcom has had unfettered use of all facilities and equipment of East End.

39. Norcom has determined and carried out policy decisions on behalf of East End.

40. Norcom has been in charge of the employment, supervision and dismissal of personnel on behalf of East End.

41. Norcom has been in charge of the payment of financial obligations, including expenses arising out of operation of the Station.

42. Norcom has paid all financial obligations, including expenses arising out of operation of the Station.

43. Norcom has received all monies and profits from the operation of facilities or equipment owned or leased by East End.

44. Norcom has retained for its benefit all monies and profits from the operation of facilities or equipment owned or leased by East End.


