Counsel for the above-specified parties were just made aware that the Presiding Judge released an *Order* scheduling the prehearing conference and the hearing date in this matter. See *Order*, FCC 98M-121, released October 30, 1998. Neither counsel for Norcom or the Associations were served with a copy of that *Order*, nor was the *Order* published in either the Commission's daily list of actions taken or *Federal Register*.

Counsel for Norcom will be out of town on the 15th of December on a business engagement made without knowledge of the *Order* and will be unable to attend the prehearing


