## RURAL HEALTH CARE CORPORATION REQUEST FOR EXTENSION OF INITIAL FUNDING YEAR

### PLEADING CYCLE ESTABLISHED

CC Docket No. 96-45

**Comment Date: December 14, 1998**

On May 8, 1997, the Federal Communications Commission ("Commission") released an Order which, among other things, established the federal universal service support mechanisms for schools, libraries, and rural health care providers.<sup>1</sup> In the *Universal Service*

*Order*, the Commission concluded that the funding year for the schools and libraries and the rural health care support mechanisms would be the calendar year.<sup>2</sup> Rural health care providers are required to reapply for universal service support each year.<sup>3</sup> In the *Fifth Order on Reconsideration and Fourth Report and Order*, the Commission reconsidered its decision regarding the funding year for the schools and libraries universal service support mechanism.<sup>4</sup> The Commission concluded that it is in the public interest to change the funding year for the schools and libraries universal service support mechanism from a calendar year cycle (January 1 - December 31) to a fiscal year cycle (July 1 - June 30).<sup>5</sup> In order to accommodate the transition to a fiscal year funding cycle, the Commission established the first funding period as the 18-month period that runs from January 1, 1998 through June 30, 1999.<sup>6</sup> The Commission did not address changes to the funding year for the rural health care support mechanism in the *Fifth Order on Reconsideration and Fourth Report and Order*.

The Rural Health Care Corporation (RHCC) submitted 2 letters requesting that the Commission extend until June 30, 1999, the initial funding cycle for the rural health care universal service support mechanism, and make the funding cycle consistent with that of the schools and libraries support mechanism.<sup>7</sup> RHCC states that this extension is necessary to allow the current applicants to conclude negotiations with the telecommunications service providers, and take advantage of the time already invested in participating in the application process.<sup>8</sup> RHCC further explains that granting the extension is advantageous because it would provide RHCC and the Commission with additional time to implement changes to improve operations.<sup>9</sup> We seek comment on RHCC's requested extension, as well as on whether the Commission should change the funding year for the rural health care support mechanism from a calendar year cycle (January 1 - December 31) to a fiscal year cycle (July 1 - June 30).

### Procedure for Filing

All filings should reference: Rural Health Care Corporation Request for Extension of Initial Funding Year, CC Docket No. 96-45, and should include the DA number shown on this Public Notice. Interested parties must file an original and six copies of their comments with the Office of Secretary, Federal Communications Commission, 445 Twelfth Street, S.W., Room TW-A325, Washington, D.C. 20554. In completing the transmittal screen, commenters should include their full name, Postal Service mailing address, and the lead docket number for this proceeding, which is Docket No. 96-45. Parties not submitting their comments via the Internet are also asked to submit their comments on diskette. Parties submitting diskettes should submit them to Sheryl Todd at the address noted above. Such a submission should be on a 3.5 inch diskette formatted in an IBM compatible format using WordPerfect 5.1 for Windows or compatible software. The diskette should be accompanied by a cover letter and should be submitted in "read only" mode. The diskette should be clearly labelled with the party's name, proceeding (including the lead docket number in this case, Docket No. 96-45, type of pleading (comment or reply comment)), date of submission, and the name of the electronic file on the diskette. Each diskette should contain only one party's pleadings, preferably in a single electronic file. In addition, parties must send copies to the Commission's copy contractor, International Transcription Service, Inc., 1231 20th Street, N.W., Washington, D.C. 20036.
