

Dear Ms. Thurrott:

This letter is to request that you provide U S WEST with a copy of any confidential materials that Southwestern Bell and Pacific Bell have filed with the FCC in support of their Long-Term Number Portability Tariffs in the above-captioned matters. U S WEST has executed the Protective Order that the Commission has entered for these proceedings, and originals of the executed declarations are attached to this letter. Paragraph 11 of that Order permits Reviewing Parties to use Confidential Information for purposes of the proceeding "including any subsequent judicial or administrative review."
