Dear Commissioners:

Telcordia Technologies, formerly Bellcore, is serving as a consultant to the Texas Public Utility Commission ("PUC") in its evaluation of certain Southwestern Bell Telephone Company ("SWBT") operation support systems ("OSSs"). In a March 24 letter to the PUC, MCI made a number of incorrect and unwarranted allegations of supposed Telcordia conflict of interest and inadequacies of the test plan that Telcordia prepared for the PUC's consideration. In a March 18 letter, AT&T expressed similar concerns. Because MCI and AT&T attacked Telcordia's integrity and professional reputation, as well as the collaborative process established by the PUC which Telcordia supports, we felt it was important to respond briefly and go on record in assuring the PUC that Telcordia is committed to maintaining the integrity of our engagement and performing it in a professional, fair and unbiased manner.


Telcordia's Work Is Unbiased. Telcordia has been hired as a consultant to the PUC. In this engagement, Telcordia takes its direction solely from the PUC and provides its deliverables solely to the PUC, or otherwise if directed by the PUC. The engagement team working on this activity is separate from other Telcordia work, including work that Telcordia performs for SWBT. At the direction of the PUC, Telcordia is to be compensated for its work by SWBT, but Telcordia provides information to SWBT regarding this engagement only with the approval of the PUC or its staff. Any contentions about these matters to the contrary are simply incorrect.

The fact that Telcordia performs other work for SWBT does not create a conflict of interest. Like most providers of telecommunications services and equipment, Telcordia performs work for a very broad variety of domestic and international clients, many of whom are competitors. Telcordia operates with a combination of procedures that assure protection of client proprietary information and that the work will be performed professionally, so as to meet individual needs objectively and without bias. We want to assure you that this is the case of all of Telcordia's undertakings, including this one for the PUC.

Telcordia Supports the PUC's Collaborative Process. In recognition of the complexity of the statistical, testing and operational issues potentially involved, the PUC instituted a collaborative process in which PUC staff, Telcordia, MCI, AT&T, other CLECs and SWBT are to participate. In response, the participants formed a Technical Advisory Group (TAG) to meet weekly. MCI, and to a lesser extent AT&T, criticizes certain aspects of the test plan that Telcordia developed based upon discussions in the TAG sessions. Certain points raised in the MCI and AT&T letters were addressed in the course of that process. Telcordia is committed to supporting the cooperative, collaborative process established by the PUC to address the issues raised by all parties. We believe that such a collaborative process is better adapted to resolution of technical issues than formal filings by parties with the PUC, and we anticipate that remaining MCI and AT&T concerns will be addressed in that process and by the PUC.

In summary, Telcordia is committed to the performance of this engagement for the PUC in a professional, fair and totally unbiased manner – which is what the PUC expected when it selected Telcordia.
