Please be advised that yesterday morning James Smith, Ameritech-Ohio, Richard Hetke, Ameritech Corp., Martin E. Grambow, SBC Telecommunications, Inc., Austin C. Schlick, counsel to SBC Communications Inc. and the undersigned met with Thomas G. Krattenmaker, Robert C. Atkinson, Michelle Carey, Frank G. Lamancusa, William Dever, Mark Siefert, Anthony Dale and Johanna Mikes of the Commission's staff regarding the above-referenced transfer of control applications. SBC and Ameritech representatives discussed with staff potential conditions concerning general compliance measures and the deployment of advanced telecommunications services. In a separate meeting yesterday, Messrs. Hetke, Grambow and Schlick met with Messrs. Lamancusa, Siefert and Dale to discuss potential enforcement and compliance measures in connection with the proposed merger.

Yesterday afternoon, Mr. Smith and I met with Mr. Krattenmaker, Ms. Carey, Mr. Dever, Ms. Mikes and Mr. Jake E. Jennings and discussed potential conditions regarding the deployment of advanced telecommunications facilities and services and other commitments designed to promote competition and benefit consumers. Later, we were joined by Mr. James D. Schlichting and Mr. Peter Wolfe of the Wireless Telecommunications Bureau and discussed the issues of "calling party pays" and paging interconnection.
