All of these conversations dealt with issues of concern relating to implementation of the new 39 GHz application processing policies adopted on July 14, 1999 by the Commission. See Memorandum Opinion and Order, ET Docket 95-183, PP Docket No. 93-253, FCC 99-179 (released July 29, 1999). A principal focus of the discussions was prospects for Commission adoption in the above-referenced rulemaking of a stay of application dismissals to, among other things, reduce administrative burdens on the Commission pending the outcome of impending further review proceedings.
