I. INTRODUCTION

1. Before the Federal Communications Commission (Commission) is submitted, pursuant to the conditional acceptance **ORDER** regarding the Region-20 and 28 Plans¹, this **RESPONSE STATEMENT** concerning the resolution of *inter*-regional channel assignment conflicts.

II. RESPONSE STATEMENT

2. In the **ORDER**, the Commission confirmed that the oppositions² to the Region-20 Second Filing Window Plan Amendments “alleged interference from Region 20 frequency channels that were previously accepted by the Commission”³. The Commission further legally noted that “those objections are moot.”⁴

3. On August 21, 1998, Region-20 filed a **WRITTEN EX PARTE PRESENTATION** which included the Regions 20 & 28 mutually agreed to **INTER-REGIONAL COORDINATION PROCEDURES AGREEMENT**⁵ (**AGREEMENT**). However, the Commission has withheld adoption of this **AGREEMENT** due to opposition from the Commonwealth of Pennsylvania on the grounds that the channels currently assigned and in use by Carroll County, Maryland will cause future harmful interference to them.

4. In the **ORDER**, the Commission noted that previously accepted channel assignments “are not open to re-negotiation unless agreed to by the parties”⁶. In the spirit of cooperation and continued desire to resolve potential *inter*-regional conflicts, Region-20 has waived its rights under the **ORDER** and opened for re-negotiation previously Commission accepted channel assignments.

5. After months of intensive deliberations between Regions 20, 28 & 36, an **INTER-REGIONAL CHANNEL RE-ASSIGNMENT AGREEMENT (RE-ASSIGNMENT AGREEMENT)** resolution to all apparent *inter*-regional channel conflicts has been achieved. This **RE-ASSIGNMENT AGREEMENT** (Attachment A) entails a multi-channel, multi-regional frequency resort, resulting in fifty-five (55) channel changes to Region-28's matrix, forty-one (41) channel changes in Region-36's matrix, and seven (7) channel changes in Region-20's matrix. These changes were based upon Region-20's Second Filing Window, Region-28's Fifth Filing Window, and Region-36's First Filing Window assignments.

6. Concomitantly filed on this date is a **SECOND ADDENDUM TO THE REGION-20 821 MHz PUBLIC SAFETY PLAN SECOND FILING WINDOW AMENDMENTS (SECOND ADDENDUM)**. This **SECOND ADDENDUM** incorporates the channel changes pursuant to paragraph 5 supra.

III. CONCLUSION

3. With the submission of this **RESPONSE STATEMENT, SECOND ADDENDUM** and the **EX PARTE PRESENTATIONS** of January 30, 1997 and August 21, 1998, Region-20 hereby fulfills the requirements of the conditional acceptance **ORDER**.

4. Region-20 requests Commission issuance of an unconditional **MEMORANDUM OPINION AND ORDER** acknowledging the acceptance of the Region-20 filings and the removal of all contingencies from the **ORDER** of December 9, 1996.



5. Upon Commission issuance of an unconditional **MEMORANDUM OPINION AND ORDER**, the Region-20 RPRC shall hereby incorporate the mutually agreed upon *inter*-regional coordination procedures by substitution of Section 32, in its entirety thereof, of the Region-20 Plan with the **INTER-REGIONAL COORDINATION PROCEDURES AGREEMENT** dated July 31, 1998.

6. Additionally and *only* upon issuance of an unconditional **MEMORANDUM OPINION AND ORDER**, it is requested by Region-20 that the **PETITION FOR EMERGENCY DECLARATORY RULING**⁷, filed against Region-28, be withdrawn without prejudice.

7. Commission issuance of an unconditional **MEMORANDUM OPINION AND ORDER** in this matter is appreciated by Regions-20 and its constituents, and is in the **public interest**.

I. INTRODUCTION

1. Pursuant to the conditional acceptance **ORDER** regarding the Region-20 and 28 Plans¹, *infra* is the mutually agreed upon **INTER-REGIONAL CHANNEL RE-ASSIGNMENT AGREEMENT (RE-ASSIGNMENT AGREEMENT)**.

II. INTER-REGIONAL CHANNEL RE-ASSIGNMENT AGREEMENT

2. On August 21, 1998, Region-20 submitted a **WRITTEN EX PARTE PRESENTATION** which contained, as Attachment A, the Regions 20 & 28 mutually agreed to **INTER-REGIONAL COORDINATION PROCEDURES AGREEMENT (COORDINATION AGREEMENT)**. The Commission has withheld adoption of the **COORDINATION AGREEMENT** due to opposition by the Commonwealth of Pennsylvania² (Pennsylvania) and their concern regarding potential interference from the Carroll County, Maryland (Carroll County) 821 MHz system.

3. After extensive negotiations, a resolution has been reached regarding *inter-regional* frequency conflicts, particularly those potential interference issues between Pennsylvania and Carroll County (Appendix A). This negotiated **RE-ASSIGNMENT AGREEMENT** consists of 103 frequency re-assignments resulting in fifty-five (55) channel changes to Region-28's matrix, forty-one (41) channel changes to Region-36's matrix, and seven (7) channel changes to Region-20's matrix. These negotiations were based upon frequency assignments made as the result of Region-36's first, Region-20's second, and Region-28's fifth filing windows.

4. This **RE-ASSIGNMENT AGREEMENT** was further possible only with the cooperation of multiple licensed entities agreeing to the re-assignment of new channels in substitution for their present allocations. Should the Commission approve this **RE-ASSIGNMENT AGREEMENT**, then several public safety entities will be required the submit license modification applications of their existing station authorizations.




