FRONTIER AND GLOBAL CROSSING SEEK FCC CONSENT TO TRANSFER CONTROL OF LICENSES AND AUTHORIZATIONS FROM FRONTIER TO GLOBAL CROSSING

Frontier Corporation ("Frontier") and Global Crossing Ltd. ("Global Crossing") have filed applications pursuant to Sections 214 and 310(d) of the Communications Act of 1934, as amended, 47 U.S.C. §§ 214 and 310(d), seeking Commission consent to transfer control of licenses and authorizations currently controlled by subsidiaries and affiliates of Frontier to Global Crossing. As listed below, these applications pertain to licenses for paging, cellular, cable television relay, business radio, industrial/business radio, telephone maintenance, point-to-point microwave, and authorization pursuant to 47 U.S.C. § 214.

Final action will not be taken on these applications earlier than 31 days following the date of this Public Notice. See 47 U.S.C. § 309(b). Interested parties may file comments or petitions to deny no later than **June 15, 1999**. Oppositions to such pleadings may be filed no later than **June 25, 1999**. Replies to such oppositions may be filed no later than **June 30, 1999**. All filings concerning matters referenced in this Public Notice should refer to **DA 99-921**, and reference specific file numbers of the individual applications.

Pursuant to 47 C.F.R. § 1.200(a), which permits the Commission to adopt modified or more stringent *ex parte* procedures in particular proceedings if the public interest so requires, we announce that this proceeding will be governed by **permit-but-disclose** *ex parte* procedures that are applicable to non-restricted proceedings under 47 C.F.R. § 1.1206.
