**SUPPLEMENTAL COMMENTS**

Legend Broadcasting, Inc. ("Legend"), by its attorney, hereby files Supplemental Comments in response to the Comments filed by Fred R. Flinn ("Flinn") in the above-referenced proceeding. In support thereof, the following is respectfully shown:


Docket No. 99-140 was initiated by Legend and proposed the reallocation of Channel 255C from Kennett, Missouri to Keiser, Arkansas and the modification of Station KTMO's license accordingly. Legend filed a counterproposal in the proceeding proposing the reallocation of Channel 255C from Kennett to Munford, Tennessee and a modification of the Station license, as well as the allotment of Channel 254A to the community of Friars Point, Mississippi. Flinn initiated Docket No. 99-146, proposing the allotment of Channel 254A to North Tunica, Mississippi. The proposals of Legend and Flinn are mutually exclusive.

On September 17, 1999, the Commission released its Public Notice accepting Legend's Counterproposal in Docket No. 99-140. Report No. 2362. On October 4, 1999, Flinn filed Comments in Docket No. 99-140, in response to the Commission's Public Notice. Flinn proposes that Channel 255C1 be reallocated to Munford to allow the allotment of Channel 254A at North Tunica. However, Legend has expressed an interest in the allotment of Channel 255C at Munford. Flinn's effort to substitute Channel 255C1, a channel in which no interest has been expressed, is contrary to law and must be rejected by the Commission.

Accordingly, for the reasons stated herein, Legend respectfully requests that the Commission reallocate Channel 255C at Munford, Tennessee.


