ADDITIONAL REPLY COMMENT

The Renaissance Community Improvement Association, Inc. has just received a document entitled "Comments in Opposition to Proposed Rule Making" filed by J. Dominic Monahan, as counsel for Klamath Basin Broadcasting. The petitioner does hereby make the following additional reply comments:

1. Klamath Basin Broadcasting is not a party to either of the applications to build and operate a new FM radio station at Keno, Oregon.
2. Klamath Basin Broadcasting did not make the presentation that they want to apply for a radio station to serve Keno, Oregon.
3. The Renaissance Community Improvement Association, Inc. is an Oregon non-profit corporation in good standing with registry number 678628-89. Attached is a copy of the Articles of Incorporation filed with the State of Oregon. No other corporation, either for profit or non-profit, has ever used

the name "Renaissance Community Improvement Association, Inc."
in the State of Oregon besides this corporation.

4. The entire opposition to the proposed rule making appears to be nothing more than a personal attack on one of the directors of the Renaissance Community Improvement Association, Inc. Please see the attached "Reply Comments to Personal Attack". THE BACKGROUND OF THE PETITIONER IS NOT A RELEVANT MATTER IN A RULE MAKING PROCEEDING. What is relevant is whether a second FM Channel should be allocated to Keno, Oregon.

SUMMARY

5. The comments filed by Klamath Basin Broadcasting in opposition to the proposed rule making are nothing more than an unfounded personal attack on one of the directors of the petitioner corporation. The background of the petitioner is not relevant and is not appropriate in a rule making proceeding.

Reply Comments to Personal Attack

While it is not relevant to this rule making, Sandra Soho would like to make the following reply comments to the personal attack made upon her by Klamath Basin Broadcasting:

a) The trouble that she got into in regards to prescribing medicine to two patients as a licensed California physician was resolved by the charges being reduced to misdemeanors and the case then being dismissed. Attached is a copy of the court minute order. The allegations made by Klamath Basin Broadcasting regarding this matter are clearly a vicious, unwarranted and unreasonable attack on a potential competitor.

b) The short period of time that she was in Chapter 13 reorganization bankruptcy was as a result of three radio station construction permits, viz. Avenal (CA), Earlimart (CA) and Lindsay (CA), that she sold for William Zawila as his agent. William Zawila signed sale contracts and accepted money, but then he would not go through with the deals and refused to refund the money. The matter ended up in nasty civil litigation with her in the middle as the agent.

c) She makes some extra money by being the registered agent for numerous Oregon corporations. There clearly is no criminal duplicity in that.


d) She also has been doing engineering for FCC construction permit applications for over 22 years. During the last 22 years, she has placed her signature on the engineering sections of over 300 construction permit applications. There clearly is also no criminal duplicity in that.
