**MOTION TO ACCEPT SUPPLEMENT TO
“COMMENTS AND ALTERNATE PROPOSAL”**

Desert West Air Ranchers Corporation (“Petitioner”), permittee of Station KFMR(FM), Winslow, Arizona, by its counsel, hereby requests leave to submit a supplemental pleading in response to the “Reply Comments and Withdrawal of Objection” filed by Capstar Royalty II Corporation (“Capstar”), licensee of Station KTTI(FM), Yuma, Arizona. In its Reply Comments, Capstar withdrew its expression of interest in filing an application for a Class C station at Yuma. In view of the fact that this new development could not have been addressed in earlier comments by Petitioner and has a direct impact on whether the Petitioner’s proposal at Sun City West can be favorably resolved, Petitioner seeks leave to file this Supplement. This Supplement proposes a new transmitter site for the Sun City West proposal which could not have been proposed in an earlier filing consistent with the Yuma Class C allotment but which can now be proposed consistent with the deletion of Channel 236C at Yuma. The Commission can accept this Supplement as a matter within its discretion in order to resolve the proceeding. See, e.g., South Congaree and Batesburg, South Carolina, 5 FCC Rcd 7480, 7483 n.3 (MM 1990) and Live Oak and St. Augustine, Florida,




