**COMMENTS OF CENTENNIAL BROADCASTING LICENSE, LLC**

Centennial Broadcasting License, LLC ("Centennial"), licensee of KSTJ(FM), Boulder City, Nevada, hereby submits its comments in response to the FCC Public Notice, Report No. 2378, released January 11, 2000, in MM Docket No. 99-271.<sup>1</sup>

In reply comments submitted in this docket on October 27, 1999, Centennial proposed the following changes to the FM Table of Allotments, in response to comments that had been filed following issuance of the Notice of Proposed Rulemaking in this docket:

Centennial continues to believe that modification of the FM Table to request the channel allotments set forth in its October 27, 1999 reply comments would be in the public interest. Centennial hereby specifically reiterates that if the proposal set forth in its reply comments is adopted, it will file an application for a construction permit to modify the facilities of KSTJ(FM), build the modified facilities, and commence such modified operations as promptly as possible upon grant of the application.




