Persons, including heirs or personal representatives of such persons, now or later serving as Directors or officers of Garden Valley Telephone Company shall be indemnified by the Company to the extent and in the manner provided by Minnesota Law as now in effect and as hereby amended, against actual expenses incurred by them in connection with threatened, pending, or completed actions or suits whenever brought because they are or were such a Director or officer, providing they acted in good faith and in a manner they reasonably believed to be in or not opposed to the best interests of the Garden Valley Telephone Company.

This is in response to your request for a refund of the Fiscal Year (FY) 1994 and FY 1995 regulatory fees paid by the Garden Valley Telephone Company (Garden Valley), and, on behalf of Garden Valley, by the National Exchange Carrier Association, Inc. You maintain that Garden Valley is incorporated as a non-profit entity under Section 308A.101 of the laws of the State of Minnesota. In support, you have submitted a Certificate of Good Standing, issued by the State of Minnesota, showing that Garden Valley was organized as a corporation governed by Chapter 308A of the Minnesota Statutes.

In establishing the regulatory fee program, Congress provided an exemption from the fee requirement for nonprofit entities. 47 U.S.C. § 159(h). In its adoption of the rules implementing the fee program, Implementation of Section 9 of the Communications Act, 10 FCC Rcd 12759 (1995), the Commission exempted from the regulatory fees:

. . . an organization duly qualified as a nonprofit, tax exempt entity . . . or an entity with current certification as a nonprofit corporation or other nonprofit entity by a state or other governmental authority.



Chapter 308A of the Minnesota Statutes governs cooperative organizations. There is nothing in the statute, however, which would prohibit Garden Valley from providing services for a profit, and the records of the Secretary of State of the State of Minnesota do not indicate that Garden Valley is a non-profit entity.

Thus, the Certificate from the Secretary of State is insufficient to establish that the Garden Valley Telephone Company is a non-profit organization and your request for a refund of the FY 1994 and FY 1995 regulatory fees must be denied. However, in view of your representations that Garden Valley is a non-profit entity, you may refile the refund request, with more appropriate documentation, within 30 days from the date of this letter.


