COMMENTS

Wing-&-A-Prayer Broadcasting Company ("WPBC"), by counsel, and pursuant to Section 1415 of the Commission's rules, hereby submits its comments in support of the *Notice of Proposed Rule Making*, DA 00-67 (released January 14, 2000) ("NPRM"), proposing the allotment of Channel 296C3 to Alva, Oklahoma, as an additional local aural service.

WPBC initiated this proceeding through its "Petition for Rulemaking," filed December 6, 1999. If the Commission should adopt its proposal and allot Channel 296C3 at Alva, WPBC hereby states that it will apply for a construction permit for a new FM station to operate on Channel 296C3 at Alva, Oklahoma, and, if its application is granted, will promptly construct the new facility to serve Alva and the surrounding area.

As noted in the NPRM, Channel 296C3 can be allotted to Alva in compliance with the Commission's minimum distance separation requirements without a site restriction. Therefore, the proposed allotment of Channel 296C3 at Alva, Oklahoma, would serve the


