

We received a notification from you indicating that the 1999-2000 application from the Austin Independent School District (ISD), Austin, Texas has been denied due to a violation of the 28-day waiting period. We disagree with and are appealing this decision.

There are two related reasons we would like to present which are the basis for this appeal:

1. Our Form 470 and our Form 471 were signed 29 days apart. Form 470 was signed March 3, 1999 and Form 471 was signed on March 31, 1999. The Form 470 was filed electronically on March 3, 1999 and posted on the SLD Web Site on March 4, 1999. The 28th day was March 31, 1999 and our Form 471 was signed at the end of this business day and promptly mailed to you for processing, recognizing the potential postal delivery delays associated with the Easter weekend.

United States Postal Service Return Receipt indicates that the SLD received the documents on April 5, 1999. Consequently, Form 470 was posted an additional 5 days on the SLD Web Site, for a total of 34 days. During this period, Austin ISD received no inquiries regarding the posting.

2. According to FCC rules, requests for new services must be posted on the SLD Web Site for a period of 28 days before signing any contracts with service providers. In fact, Austin ISD had a pre-existing contract with IBM signed on November 11, 1997 which was a multi-year contract structured to coincide with the E-Rate eligibility requirements and consistent with Texas competitive bidding laws. The IBM contract respected the E-Rate eligibility requirements of having portions of eligible work performed in calendar year 1998 and subsequent portions performed in calendar year 1999. However, the SLD regulations regarding pre-existing contracts for the 1999-2000 application period defined an "existing, written binding contract" as one that was signed on or before July 10, 1997. Accordingly, we could not check Block 3, Number 10, "Check if applicant seeks discounts only for eligible services based on one or more existing, binding contract(s)." Although we did not have an existing contract prior to July 10, 1997, we did have one in place by November 11, 1997, and clearly had a relationship with our vendor at the time of the 1999-2000 application.

As stated previously, during the Form 470 posting period no vendors contacted the Austin ISD, and irrespective of the March 31, 1999 date the Form 471 was signed, no contract was entered into during the 28 day posting period, nor earlier than April 1, 1999. In fact, having received no additional vendor interest, Austin ISD proceeded with the final negotiations with IBM for 1999 year work, which included technology infrastructure work beyond the E-Rate eligible work, well after the April 1, 1999 date.

For the 1998-1999 E-Rate program year we received over \$2 million which has helped achieve technology goals for many of Austin's most needy children. We followed the same procedures when we completed the 1999-2000 E-Rate application. It would be extremely unfortunate if we lose the opportunity to provide technology for additional students in this under-served population. We appreciate the reconsideration of our application and anticipate a timely response to this appeal. Please contact us if you need additional information or documentation.

On April 5, 1999, the Austin Independent School District applied to the USAC for \$1,100,000 for telecommunications. On November 2, we were notified by the USAC that this application was denied because of a violation of the 28-day waiting period. We would like to appeal this denial for two reasons:

1. Our Form 470 and our Form 471 were actually signed 29 days apart thus meeting the 28-day requirement. Form 470 was signed and dated March 3, 1999 and Form 471 was signed and dated on March 31, 1999. Although Form 470 was filed electronically on March 3, the SLD did not post it until March 4, resulting in the apparent violation of the 28-day waiting period.

United States Postal Service Domestic Return Receipt indicates that the SLD received Form 471 on April 5, 1999. Consequently, Form 470 actually was posted an additional 5 days on the SLD web site for a total of 34 days. During the entire 34-day period, Austin ISD received no inquiries regarding the posting.

2. The District actually was not required to post a bid at all because we followed local and state purchasing policies. Every request in Form 471 application number 142908 was for tariffed or month-to-month telecommunications services. Each of these services comes from a state contract that the State of Texas General Services



Commission (GSC) has entered into in order to give school districts the lowest possible rates. The GSC conducts extensive competitive bidding to select vendors who provide good service at the lowest possible rates. School Board policies encourage using state General Services Commission contracts which our research indicates offer the lowest available rates. The District does not issue a contract to these state-approved vendors; it merely creates a purchase order for these services. In some cases, such as with pagers, the District orders what is needed using neither a contract nor a purchase order.

E-Rate funds have helped achieve technology goals for many of Austin's most needy children. The same procedures that we used successfully in 1998-1999 were followed when completing the 1999-2000 E-Rate application. It would be extremely unfortunate if AISD were to lose the opportunity to provide technology for additional students in this under-served population.

We appreciate the reconsideration of the application and anticipate a timely response to this appeal. Please contact us if we can provide additional information or documentation.





If this date was before the 28th day after the posting date of your Form 470, then your application did NOT comply with the program rules governing the preparation and submission of Form 471. In this case, the 470 has an allowable contract date of 4/1/99 and the 471 was signed 3/31/99.
