Yesterday Mark Pitchford, Jane Kunka and the undersigned attorney, on behalf of Qwest Communications International Inc. ("Qwest"), held a telephone conference call with Lisa Choi, Eric Einhorn, Claudia Fox, Chris Libertelli, Pam Megna, Bill Rogerson, Jackie Ruff, Daniel Shiman and Mark Uretsky of the Commission regarding the above-referenced proceeding.

The discussion focused on Qwest's experiences and perspectives regarding the provision of mass market long distance services. Qwest described its offerings and business approach for this market segment, as well as its decision to rely on methods other than national advertising to attract and keep customers. Qwest discussed the dynamics of competing against the largest long distance carriers for "1+" and dial-around services, as well as its experiences with customer churn. The parties also addressed the significance of a recognizable brand name in marketing and selling to consumers, and the extent to which customers may prefer to purchase multiple services now and in the future from a single carrier.


