Dear Ms. Salas:

This letter is to update the Divestiture Compliance Report of Qwest Communications International Inc. ("Qwest"), filed April 14, 2000 in the above-referenced docket, concerning the activities of Apex Global Information Services, Inc. ("AGIS"). In the Report Qwest noted that AGIS had filed for Chapter 11 bankruptcy. Qwest also indicated that prior to closing of its merger with U S WEST, Inc., Qwest would take steps as necessary to reduce its interest in AGIS such that AGIS would no longer be an affiliate for purposes of Section 271. (Report at 93-95.)

Subsequent events have eliminated the need for Qwest to reduce its interest in AGIS. On May 19, 2000, pursuant to an order of the US Bankruptcy Court, AGIS sold substantially all of its business assets to Telia Internet, Inc. and ceased its business operations. A copy of the order is attached. AGIS will now be liquidated pursuant to a plan to be overseen by the Court. Because AGIS is not providing any services, Qwest's position with respect to this debtor company presents no Section 271 issues.

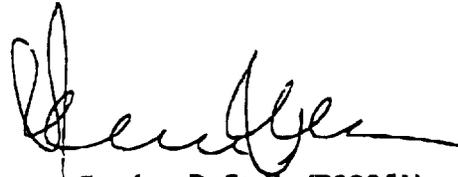
