



These authorizations, however, are the subject of a currently pending transaction, which has been consented to by the FCC but which the parties have not yet closed, seeking the assignment of the same authorizations from Digital PCS, LLC (File No. 0000043577). Because the parties anticipate that the underlying transaction will be consummated by the time the TeleCorp/Tritel merger closes, the parties are seeking consent for this follow on transaction. Because ULS does not presently permit the applicants to file the requested transfer of control of those authorizations electronically due to the prior pending application, for these authorizations, the applicants have filed a paper FCC Form 603 and request a waiver of the electronic filing requirement.

EXHIBIT B: SUPPLEMENTAL DESCRIPTION

In Exhibit A attached hereto, the applicants indicate that they are seeking consent to the assignment of certain authorizations from Tritel License-Florida, Inc. ("T-FL") and Tritel License-Georgia, Inc. ("T-GA") to Panther Wireless, L.L.C. ("Panther"). At present, neither T-FL nor T-GA hold any authorizations, merely the contractual right to obtain certain authorizations from Digital PCS, LLC ("Digital"). The FCC has consented to the assignment of the specified authorizations from Digital to T-FL (see File No. 0000043577) and from Digital to T-GA (see File No. 0000043606), but those transactions have not yet been consummated, and, indeed, may not be consummated prior to the closing of the TeleCorp/Tritel merger. To avoid any delay or further complication of the TeleCorp/Tritel merger, the parties, upon further reflection, are not seeking authority to assign any potential licenses held by T-FL or T-GA to Panther. Rather, the parties are seeking authority for the transfer of control of T-FL and T-GA from Tritel, Inc., their ultimate parent, to TeleCorp PCS, Inc., in the event the assignments from Digital to T-FL and T-GA are closed prior to the merger.
