On July 26, 2000, Hubbard Broadcasting, Inc. ("Hubbard") and the Satellite Communications Broadcasting Association ("SBCA") timely filed an *ex parte* letter pursuant to Section 1.1206 of the Commission's Rules. The July 26 letter advised the Commission that the undersigned and Ward L. Quaal, on behalf of Hubbard, and Andy Paul of the SBCA met on July 26 with Robert H. Ratcliffe, Barbara Kreisman, Clay Pendarvis, H. John Morgan, and Gordon W. Godfrey of the FCC's Mass Media Bureau to discuss Hubbard's concerns regarding a proposal by Northpoint Technology Ltd. to operate a point-to-multipoint microwave system in the 12.2-12.7 GHz Band.

The July 26 letter inadvertently omitted Keith Larson of the Mass Media Bureau, who also attended the meetings described above.

Hubbard is the previous owner of USSB and is a significant shareholder in DirecTV.
