MOTION TO STRIKE

Island Prime Media ("petitioner"), by counsel, herewith submits its motion to strike the counterproposals submitted by Aurio A. Matos and Juan Carlos Matos ("Matos") and by Arso Radio Corporation ("Arso") in this proceeding. The Arso counterproposal is set forth in the REPLY COMMENTS OF ARSO RADIO CORPORATION. It seeks to modify the Matos counter-proposal to substitute Channel 300A for Channel 258A in Frederiksted.

1. The Appendix to the NPRM, at para. 3(a) states:

Counterproposals advanced in this proceeding itself will be considered, if advanced in initial comments, so that parties may comment on them in reply comments. They will not be considered if advanced in reply comments. (See Section 1.420(d) of the Commission's Rules).

2. The Commission clearly stated that counterproposals may not be advanced in Reply Comments, and Arso's proposal to advance a counterproposal at this stage of the proceeding must be stricken. That portion of the Arso pleading which demonstrates that the Matos counterproposal includes a conflict with Channel 247C in the British Virgin

Islands may be considered and, in light thereof, the Commission should also strike the Matos counter-proposal as defective.




