Dear Ms. Salas:

Choice Wireless, LC ("Choice") hereby files its report on implementation of Wireless E911 Phase II Automatic Location Identification ("ALI") (CC Docket No. 94-102) pursuant to Section 20.18(i) of the Commission's Rules.¹

Choice began offering wireless service on November 1, 2000. To date, Choice has not received a Phase II request from a PSAP that is capable of receiving and utilizing the data elements and that has a mechanism in place for recovering the PSAP's costs. Accordingly, this report does not reference any schedules for installation of the hardware and/or software needed to implement E911 Phase II ALI and does not contain a TRS number.

At this time, Choice is considering utilizing a handset-based technology but has not determined which particular vendor to use. As it investigates and negotiates with various vendors, including Tandler Cellular (see attached), it will consider whether the products offered are compatible with the recently installed facilities and whether they are available with the features required by the target subscriber base.


