By the Accounting Policy Division, Common Carrier Bureau:

1. The Accounting Policy Division has under consideration a Letter of Appeal filed by North Attleborough Public Schools (North Attleborough), North Attleborough, Massachusetts, seeking review of a decision issued by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator).<sup>1</sup> North Attleborough seeks review of SLD's refusal to consider North Attleborough's appeal to SLD on the grounds that it was untimely filed. For the reasons set forth below, we deny North Attleborough's appeal.

2. SLD issued a Funding Commitment Decision Letter on April 14, 2000, denying North Attleborough's request for discounted services under the schools and libraries universal service support mechanism.<sup>2</sup> Specifically, SLD denied North Attleborough's request for discounts for internal connections, Funding Request Number (FRN) 434670. On June 12, 2000, North Attleborough filed an appeal of SLD's decision to deny FRN 434670.<sup>3</sup> On June 14, 2000, SLD issued an Administrator's Decision on Appeal indicating that it would not consider North Attleborough's appeal because it was received more than 30 days after the Funding Commitment
