

COMMENTS OF PIGEON FORGE BROADCASTING COMPANY

Pigeon Forge Broadcasting Company ("PFBC"), by counsel, and pursuant to § 1.415 and § 1.420 of the Commission's rules and regulations, and in response to the Commission's *Notice of Proposed Rule Making*, DA00-2421, released October 27, 2000 ("*NPRM*") in the above-captioned rule making proceeding, hereby respectfully submits its comments in support of the proposed allotment of FM Channel 292A at Pigeon Forge, Tennessee as that community's first local aural transmission service,

According to the U.S. Census Bureau's Population Estimates program (Internet release date October 20, 2000), the population of Pigeon Forge, Tennessee as of July 1, 1999 was 5,424 persons. Pigeon Forge is an incorporated community and well-deserving of its first local aural transmission service.

PFBC hereby states its commitment to promptly apply for a construction permit consistent with the allotment of FM Channel 292A to Pigeon Forge, Tennessee. PFBC further states its commitment to prompt construction of broadcast facilities in accordance with the terms of the

construction permit issued by the Commission therefor, so that the community of Pigeon Forge may receive its first local broadcast transmission service at the earliest possible date.




