**ORDER**

By the Accounting Policy Division, Common Carrier Bureau:

1. The Accounting Policy Division has under consideration a Letter of Appeal filed by Caddo Independent School District 5 (Caddo), Caddo, Oklahoma, on May 1, 2000, pursuant to section 54.719(c) of the Commission's rules.<sup>1</sup> Caddo seeks review of a decision of the Schools and Libraries Division (SLD) of the Universal Service Administrative Company, denying in part Caddo's request for funding of internal connection services. For the reasons discussed below, we grant the appeal in part and remand to SLD.

2. Caddo requests review of a decision by SLD to reduce the amount of Caddo's funding request because SLD concluded that components of the request included support for an ineligible Wide Area Network (WAN).<sup>2</sup> As in *Terral School District 3*, SLD denied support for certain components despite their integration with routers deemed eligible for support by SLD.<sup>3</sup>



Consistent with *Terral School District 3*, and in the absence of an explanation by SLD of the basis for its decision, we conclude that the record does not support SLD's finding of ineligibility. Accordingly, we shall remand to SLD for further consideration.<sup>4</sup>

3. ACCORDINGLY, IT IS ORDERED, pursuant to authority delegated under sections 0.91, 0.291, and 54.722(a) of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, and 54.722(a), that the appeal filed by the Caddo Independent School District 5, Caddo, Oklahoma, on May 1, 2000 IS GRANTED to the extent provided herein. We direct the Schools and Libraries Division to review Caddo's funding application and, if warranted, to issue a revised Funding Commitment Decision Letter in accordance with the above-stated decision.
