PETITION FOR RULE MAKING

Pursuant to 47 C.F.R. 1.401, Charles Crawford respectfully petitions the FCC to institute a Rule Making proceeding to amend the FM Table of Allotments to add Channel 250A at **Batesville**, Texas.

DISCUSSION

Petitioner respectfully submits that the public interest would be served by allocating Channel 250A to **Batesville**, Texas, as that community's first aural broadcast transmission service. **Batesville** has a population in excess of 1,200 people according to the January 1, 1998 Texas State Data Center. **Batesville** has its own school system, the **Batesville Independent School System**, its own post office, and First Baptist Church of **Batesville**.
