Dear Ms. Eichenlaub:

This is in response to the request for waiver of the late charge penalty for late payment of the Fiscal Year (FY) 1999 regulatory fees, filed on behalf of WXGI AM 950.

The Communications Act of 1934, as amended, requires the Commission to assess a late charge penalty of 25% on any regulatory fee not paid in a timely manner. It is the obligation of the licensees responsible for regulatory fee payments to ensure that the Commission receives the fee payment no later than the final date on which regulatory fees are due for the year. Your request does not indicate or substantiate that WXGI AM 950 met this obligation. Therefore, your request is denied.

Payment of the late charge penalty in the amount of \$375.00 was assessed and due on September 22, 1999. The late charge penalty must be filed together with a Form FCC 159 (copy enclosed) within 30 days from the date of this letter. You are cautioned that the failure to submit payment as required may result in further sanctions and the initiating of a proceeding to recover the penalty and accrued interest pursuant to the provisions of the Debt Collection Improvement Act of 1996.
