SUPPLEMENT TO PETITION FOR REVIEW

Unicom, Inc. ("Unicom"), by its counsel, hereby supplements its October 9, 2001 Petition for Review of the Universal Service Administrative Company ("USAC") letter decision dated September 6, 2001. In footnote 3 of its Petition, Unicom referenced that Funding Commitment Letters ("FCLs") issued by the Rural Health Care Division incident to the USAC letter should be reviewed by the Commission in conjunction with Unicom's Petition. - Nunapitchuk (HCP 10175) (FCL issued September 14); and
- Yukon-Kuskokwim Delta Regional Hospital (HCP 10217) (two FCLs issued September 29).

In order to preserve its appellate rights with respect to these and other FCLs issued to Yukon-Kuskokwim Health Corporation ("YKHC"), and out of an abundance of caution, Unicom


