COMMENTS ON PETITION FOR RULEMAKING

Pursuant to Notice of Proposed Rulemaking adopted August 29, 2001, and released September 7, 2001, Robert Armstrong on behalf of Sanilac Broadcasting Company respectfully files these comments opposing a rulemaking to amend the FM TABLE OF ALLOTMENTS to add Channel 256-A at Harbor Beach, Michigan.

DISCUSSION

A one Charles Crawford, 4533 Bordeaux Avenue, Dallas Texas, 75205, has requested that this honorable Commission allocate CHANNEL 256A to Harbor Beach, Michigan

That Charles Crawford stated in his petition that if Channel 256 A would be allocated to Harbor Beach, Michigan, he would apply for Channel 256A, and after it is authorized, would promptly construct a new facility.

That Charles Crawford also stated that the information in his petition is correct to the best of his knowledge.

According to the files of the F.C.C., and according to our information and belief, Charles Crawford has applied for rulemakings for upwards of 20 channels before this Commission this year.

On information and belief, Charles Crawford has never constructed, owned, or owned and operated a radio station. That he has never shown that he has financial abilities to own and construct a radio station. The petition has not shown that if all of the channels that he as requested were allocated to him that he has sufficient assets to construct and operate these stations.




