
Statement of No Consideration

I, McHenry T. Tichenor, Jr., President of Tichenor License Corporation ("TLC"), licensee of Station KLTO(FM), Galveston, Texas (FCC construction permit granted to change community of license to Crystal Beach, Texas), do hereby state the following:

TLC filed Comments (including an "expression of interest") with the Commission on October 12, 2001, in support of the Commission's Notice of Proposed Rule Making in MM Docket No. 01-223 (released September 7, 2001) ("NPRM") which proposed the substitution of Channel 287C3 for Channel 287A at Crystal Beach, Texas, the reallocation of Channel 287C3 from Crystal Beach to Stowell, Texas, and the modification of the authorization for Station KLTO(FM) accordingly.

TLC hereby advises the Commission that it no longer has an interest in the proposal set forth in the NPRM, and therefore withdraws its expression of interest as set forth in the Comments filed on October 12, 2001. This is to further advise the Commission that no person or party has paid or promised TLC nor any party to TLC any consideration of any kind in return for TLC's withdrawal of its expression of interest in MM Docket No. 01-223.
