

REPLY COMMENTS OF MAURICE SALSA

I, Maurice Salsa, hereby respectfully submit this Reply to Comments filed by KTCY Licensing, Inc. ("KTCY") in the above captioned proceeding.

DISCUSSION

Wright City, Oklahoma is an incorporated community of over 850 people. Petitioner respectfully submits that the public interest would be served by allocating Channel 226A to Wright City, Oklahoma, as that community's first aural broadcast transmission service.

KTCY is the licensee of Radio Station KTCY (FM), Pilot Point, Texas operating on Channel 285C1. KTCY counterproposes that Channel 285C0 be added at Pilot Point, Texas and that Radio Station KTCY (FM)'s license be modified accordingly. Additionally, KTCY proposes in the above captioned proceeding a new allotment reference site for Channel 226A at Wright City. They are also proposing Channel 265A at Broken Bow, Oklahoma in lieu of Channel 285A. And finally, KTCY is proposing Channel 227A at Antlers, Oklahoma in lieu of Channel 284A.

The KTCY counterproposal cannot be accepted as it is proposed. First of all, 227A at Antlers is not available due to KKNG Newcastle, Oklahoma 227C allotment. 227A at Antlers is short -25.8 Km to KKNG 227C Newcastle. The attached channel study shows that Channel 227A cannot be allotted to Antlers, Oklahoma in compliance with the Commission's spacing rules at the site proposed by KTCY.

Additionally, 227A at Antlers, Oklahoma is not available due to a prior filed rulemaking petition for Channel 227A at Red Oak, Oklahoma. It should be pointed out that KTCY's counterproposal for Channel 227A at Antlers, Oklahoma, in lieu of Channel 284A was only timely filed as of November 16, 2001. In KTCY's counterproposal for Broken Bow, Oklahoma, MM Docket No. 01-209, KTCY did not serve the petitioner for Antlers. Therefore, KTCY's counterproposal for 227A at Antlers in lieu of 284A is only timely filed as of the date of the Antlers counterproposal, November 16, 2001. (see Exhibit 1, Certificate of Service page for Broken Bow, Oklahoma, MM Docket No. 01-209)

For the foregoing reasons, I urge the Commission to allot Channel 226A to Wright City, Oklahoma. Should the Commission allot Channel 226A to Wright City, Oklahoma, I will apply for Channel 226A, and after it is authorized, will promptly construct the new facility.

The information provided in these Reply Comments is correct and true to the best of my knowledge.


