

PETITION FOR RULE MAKING

Jeraldine Anderson (Petitioner), pursuant to 47 C.F.R. 1.401, hereby requests the commission to amend section 73.202 (b) of its rules, the FM Table of Allotments, to allot channel 241A (96.1 Mhz) at Clayton, Oklahoma.

DISCUSSION

Clayton, Oklahoma is an incorporated community of over 636 people. Petitioner respectfully submits that the public interest would be served by allocating Channel 241A to Clayton, Oklahoma, as that community's first aural broadcast transmission service. Clayton has its own mayor, Arvil Jackson, its own volunteer fire department, its own post office, its own school district and a number of local churches. There is also the Clayton City Hall and the Clayton Chamber of Commerce.

Attached hereto is a channel study confirming that Channel 241A can be allocated to Clayton, Oklahoma consistent with the FCC's FM separation rules. See revision of FM Assignment Policies and Procedures, 90 FCC 2d 88 (1992).

Petitioner hereby states that if the commission grants this petition, she will apply for the channel when it is allotted, and, if her application is granted, she will promptly build the station.


