PETITION FOR RULE MAKING

Pursuant to 47 C.F.R. 1.401, Katherine Pyeatt respectfully petitions the FCC to institute a Rule Making proceeding to amend the FM Table of Allotments to add Channel 231A at Hooks, Texas.

DISCUSSION

Petitioner respectfully submits that the public interest would be served by allocating Channel 231A to Hooks, Texas, as that community's first competing FM service. Hooks is an incorporated city with a population of 2,826 people as of January 1, 1998 according to the Texas State Data Center. Hooks has its own mayor, Michael Babb, its own post office, its own school system, its own fire department, its own city hall and a number of local churches. The proposed channel 231A to Hooks will provide additional diversity and an outlet for local self-expression to Hooks residents and therefore is in the public interest.
