COMMISSION SEEKS COMMENT ON APPLICATIONS FOR CONSENT TO TRANSFER CONTROL OF LICENSES AND AUTHORIZATIONS HELD BY AFFILIATES OF CONESTOGA ENTERPRISES, INC. TO AFFILIATES OF D&E COMMUNICATIONS, INC.

On December 26, 27, and 28, 2001, The Conestoga Telephone and Telegraph Company, CEI Networks, Inc., Conestoga Enterprises, Inc., Buffalo Valley Telephone Company, Conestoga Mobile Systems, Inc., Conestoga Wireless, Inc., and D&E Acquisition Corp. (collectively, "Applicants") filed applications pursuant to sections 214 and 310(d) of the Communications Act of 1934, as amended, 47 U.S.C. §§ 214, 310(d), requesting Federal Communications Commission ("Commission") approval to transfer control to of Commission licenses and authorizations held directly or indirectly by Conestoga Enterprises, Inc. ("CEI") to provide domestic and international telecommunications services pursuant to parts 22, 24, 63, and 90 of the Commission's rules to D&E Communications, Inc. ("D&E"), the parent company of D&E Acquisition Corp.¹ Under the terms of the proposed transfer of control, each CEI shareholder will have the option to receive cash and/or D&E common stock for his or her CEI shares. The merger would be accomplished by merging CEI with D&E Acquisition Corp., a subsidiary of D&E.

D&E is a publicly traded company that, through its subsidiaries, provides service in south central Pennsylvania. D&E provides rural incumbent local exchange service, serving approximately 61,000

local access lines, and competitive local exchange service, serving approximately 7,000 local access lines. D&E also provides long distance, Internet access, and paging services. Currently, D&E also owns a fifty percent interest in D&E/Omnipoint Wireless Joint Venture, L.P., a PCS provider in the Harrisburg, York-Hanover, Lancaster, and Reading, Pennsylvania Basic Trading Areas. VoiceStream Wireless Corporation owns the remaining fifty percent of this joint venture.² CEI is a publicly traded corporation that provides services in southeastern and central Pennsylvania. Through its subsidiaries, CEI is a rural incumbent local exchange carrier, serving approximately 84,000 local access lines, and a competitive local exchange carrier, serving approximately 14,000 local access lines. CEI also provides long-distance, Internet access, paging and cable television services, as well as PCS. The Applicants state that the merger will promote the public interest and have no adverse effect upon competition in domestic telecommunications markets.

STREAMLINED INTERNATIONAL SECTION 214 APPLICATIONS

Part 63—International Service (47 C.F.R. § 63.18)

The application listed below for consent to transfer control to D&E of international section 214 authority held by Conestoga Networks, Inc., a subsidiary of CEI, has been found, upon initial review, to be acceptable for filing and subject to the streamlined processing procedures set forth in section 63.12 of the Commission's rules.³ This application is for authority under section 214 of the Communications Act,⁴ to transfer control of a section 214 authorization for international global resale, as specified below.
