1. The Accounting Policy Division has under consideration Requests for Review filed by the above-captioned entities.¹ The above-captioned entities request review of a decision

by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company relating to their applications for discounts under the schools and libraries universal service support mechanism.² Specifically, the above-captioned entities challenged findings by SLD that their applications were not filed with SLD by the deadline for priority funding in Funding Year 4. However, since their Requests for Review were filed, SLD has granted the relief that each of the above-captioned entities sought.³ Accordingly, we dismiss the above-captioned Requests for Review as moot.

2. ACCORDINGLY, IT IS ORDERED, pursuant to authority delegated under sections 0.91, 0.291, and 54.722(a) of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, and 54.722(a), that the Request for Review by Bethel School District #52, Eugene, Oregon, filed August 24, 2001; Heartland Community Schools, Henderson, Nebraska, filed August 21, 2001; Henderson County Public Library, Henderson, Kentucky, filed August 31, 2001; Teays Valley Local School District, Ashville, Ohio, filed September 4, 2001; Wetzel County School District, New Martinsville, West Virginia, filed August 28, 2001; Ypsilanti District Library, Ypsilanti, Michigan, filed August 29, 2001, ARE DISMISSED as moot.
