REQUEST TO WITHDRAW PETITION FOR RULE MAKING

Blue Sky Broadcasting, Inc. ("Blue Sky"), licensee of FM Station KPND, Channel 237C1, Sandpoint, ID (Facility ID No. 5992), by its attorney, hereby respectfully requests the withdrawal of its February 20, 2001 "Petition For Rule Making" in the above-captioned matter.

The Petition requested amendment of the FM Table of Allotments ("FM Table") to substitute Channel 237C for Channel 237C1 at Sandpoint, ID (and modification of the license for KPND to the higher class channel) and, to accommodate the change at Sandpoint, the substitution of Channel 236C3 for Channel 237C3 at Orofino, ID (and modification of the license of KLER-FM, Orofino, ID to specify operation on Channel 236C3). To date, the Bureau has not issued a Notice of Proposed Rule Making in this matter.

On March 6, 2002, Blue Sky and the licensee of KLER-FM filed Section 73.3517 coordinated change applications, for one-step upgrade of KPND to Channel 237C, and to modify KLER-FM to operate on Channel 236C3. As these facility changes are now


