

Erratum

By the Senior Deputy Chief, Common Carrier Bureau:

1. In an order adopted December 21, 2001, the Commission terminated a list of proceedings in which final orders had been issued that were no longer subject to judicial review.¹ This Erratum reinstates two proceedings that were terminated in error.

2. On January 29, 1997, the Commission adopted an order in the Tariff Streamlining Proceeding.² AT&T Corporation, *inter alia*, filed a petition for reconsideration of that order on March 10, 1997. This proceeding was included inadvertently in docketed proceedings terminated by the Commission.

3. On December 1, 1998, the Commission adopted an order terminating an investigation into rates filed by Beehive Telephone Company, Inc. and Beehive Telephone, Inc. Nevada (collectively "Beehive").³ On March 31, 1999 and April 29, 1999, the Commission adopted an order on reconsideration and a further order on reconsideration, respectively.⁴ On April 2, 1999, Beehive petitioned the United States Court of Appeals for the District of Columbia Circuit for review, Case No. 99-1130. This proceeding also was included inadvertently in docketed proceedings terminated in the *Termination Order*.


