By the Deputy Chief, Wireline Competition Bureau:


On February 20, 2001, Verizon Communications, Inc. (Verizon) asked the Common Carrier Bureau (now the Wireline Competition Bureau) (Bureau) to clarify the Most-Favored Nation (MFN) condition in the *Bell Atlantic/GTE Merger Order* as it applies to provisions relating to payment for traffic bound for internet service providers.¹ On March 6, 2001, Birch Telecom, Inc. (Birch) asked the Bureau to likewise clarify the MFN condition in the *SBC/Ameritech Merger Order*.² On March 30, 2001, the

Bureau sought comment on both requests.³ On February 28, 2002, the Commission released the *Global NAPs Order*, which addressed the Verizon MFN provision.⁴ Meanwhile, Birch has indicated that it no longer seeks clarification from the Bureau. Accordingly, both requests are hereby dismissed as moot.
