Enclosed for filing on behalf of EchoStar Communications Corporation ("EchoStar") in the above-referenced docket, please find a CD-ROM loaded with a Microsoft Access database maintained by EchoStar that contains certain data concerning EchoStar's subscribers on a zip code and designated market area basis, as well as certain information concerning EchoStar's cable competitors. EchoStar has compiled this information from various sources and cannot vouch for its accuracy and reliability (only the competitors listed could verify the accuracy of information pertaining to them). Instructions for using the database are also included on the CD-ROM. EchoStar notes that the information it has provided in response to Interrogatory XIII-A (Exhibit XIII(A)-1) is based largely on this database.

Because this database also includes highly granular information concerning EchoStar's subscribers, EchoStar is submitting this CD-ROM, the database and the material contained therein to the Commission pursuant to the Second Protective Order released on April 25, 2002. In addition, enclosed please find an additional copy of this cover letter to be date-stamped and returned with our messenger.


