The application, as amended, is mutually exclusive with the proposed rulemaking allotment of Channel 234C3 at Valliant, Oklahoma, in MM Docket No. 01-216, and was filed before the comment date in MM Docket No. 01-216. In this light, the referenced application will be considered as a counterproposal in MM Docket No. 01-216.

To accommodate the allotment of Channel 250B1 at Belle Haven, Counterproponents request the substitution of Channel 290A for Channel 252A at Nassawadox, Virginia, at reference coordinates 37-33-43 NL and 75-44-24 WL. To accommodate the foregoing channel substitution, Counterproponents request the reallocation of Channel 291A (Station WEXM (FM)) from Exmore, Virginia, to Poquoson, Virginia, at reference coordinates 37-12-30 NL and 76-25-05 WL. Because the reallocation of Channel 291A from Exmore to Poquoson would result in the removal of the only local FM station from Exmore, Counterproponents propose the reallocation of Channel 241B (Station WROX-FM) from Cape Charles to Exmore, Virginia at reference coordinates 37-18-02 NL and 75-59-05 WL.
